**FOOD OR DRINK SALES/SAMPLES:** Any Vendor/Exhibitor wishing to hand out or sell food or drinks of any kind during the event must have prior written consent from the facility concessionaire, us & HAN as well as all proper health permits, etc.

**SPACE ASSIGNMENT:** Placement is at our discretion. End spaces are not guaranteed.

**REFUNDS:** NO refunds within 45 days of event.

**PAYMENT:** No personal or business checks will be accepted after July 1. **Cash or money order only accepted at event.**

**DISCREPANCIES:** Our business and its employees decisions is final in all discrepancies.

**DRONES:** No drones allowed to be flown on facility premises.

**VEHICLES:** No vehicles will be allowed to drive into swap meet area during swap/spectator hours. Single occupancy handicap (ADA) approved scooters only will be allowed for handicapped individuals.

**SALES TAX:** We supply Nevada Sales Tax Form. Return form and sales tax to swap office between 2:00 and 5:00 P.M. Saturday. Tax Rate is 8.265%. It is not required for exhibitor to hold a valid Resale #.

**CREDENTIALS:** 2 passes for first space and one pass for each additional space. Wrist band must be worn at all times.

**E-Z UPS** must be weighted down with appropriate weights for possible heavy winds. Vendor will be solely liable in the event that his display causes damage to another vendor, the event site property or anyone injured due to his negligence.

**WINDSHIELD STICKERS:** Must be filled out and firmly attached to lower driver side windshield.

**BREAKDOWN:** No breaking down until 2:00 p.m. Saturday.

**GENERATORS/NOISE:** Excessive stereo/display noise not allowed. No generators from 10 pm to 5 am. Fire extinguisher required with generator.

**SECURITY, LIABILITY, PROPERTY DAMAGE:** Security provided Thursday, Friday, and Saturday, but area is large and we, HAN and/or staff CANNOT assume liability for your property. We are not responsible for merchandise lost due to weather conditions.

**CAMPING:** Overnight camping in your space is permitted. No fires.

**PHOTOS:** Vendor/Exhibitor relinquishes any and all rights to any photos or video taken in connection with this event. It is understood that these photos and/or videos may be used for future promotions.
